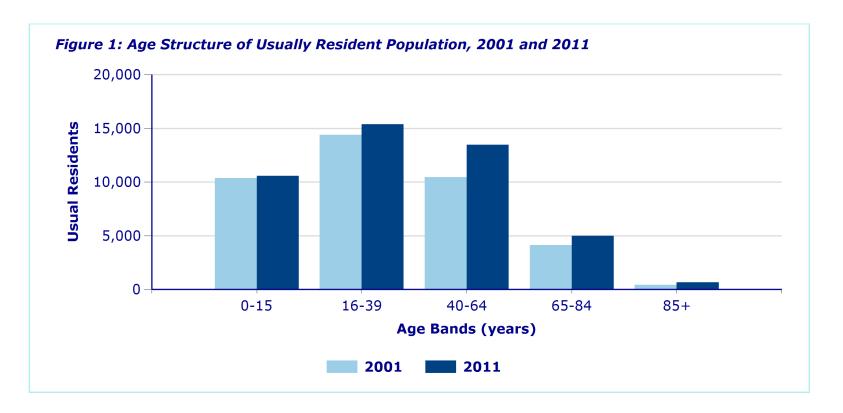
Usually Resident Population

On Census Day (27 March 2011) the usually resident population of **Magherafelt** Local Government District was **45,038** accounting for **2.49%** of the NI total.

This represents a **13.22%** increase since the 2001 Census. The table and chart below show how the age structure of the usually resident population in **Magherafelt** Local Government District on Census Day has changed between 2001 and 2011.

Population Change

The Mid-Year Estimates (MYE) of Population time series is the recommended source to examine population change over time. A new MYE time series, incorporating the 2011 Census, will be published shortly by NISRA. In the interim, since both the 2001 and 2011 Censuses reflect the full population adjusted for census under-enumeration, a comparison of the 2001 and 2011 Censuses provide a robust measure of population change over the decade.

Households

On Census Day 2011 there were **44,822** people **(99.52%)** living in **15,037** households, giving an average household size of **2.98**. The remaining **216** people **(0.48%)** were living in communal establishments.

The table below shows how the household structure of the usually resident population on Census Day has changed between 2001 and 2011.

Demography

On Census Day 27th March 2011, in **Magherafelt** Local Government District:

- 23.48% were aged under 16 years and 12.50% were aged 65 and over;
- 50.18% of the usually resident population were male and 49.82% were female; and
- **34** years was the average (median) age of the population.

Ethnicity, Identity, Language and Religion

On Census Day 27th March 2011, in **Magherafelt** Local Government District, considering the resident population:

- 0.76% were from an ethnic minority population and the remaining 99.24% were white (including Irish Traveller);
- **66.01%** belong to or were brought up in the Catholic religion and **31.48%** belong to or were brought up in a 'Protestant and Other Christian (including Christian related)' religion; and
- **31.40%** indicated that they had a British national identity, **42.68%** had an Irish national identity and **29.78%** had a Northern Irish national identity*.

On Census Day 27th March 2011, in **Magherafelt** Local Government District, considering the population aged 3 years old and over:

- 18.48% had some knowledge of Irish;
- 7.70% had some knowledge of Ulster-Scots; and
- 2.78% did not have English as their first language.

On Census Day 27th March 2011, in Magherafelt Local Government District:

- 18.45% of people had a long-term health problem or disability that limited their day-to-day activities;
- 81.42% of people stated their general health was either good or very good; and
- 10.62% of people stated that they provided unpaid care to family, friends, neighbours or others.

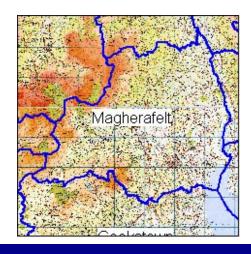

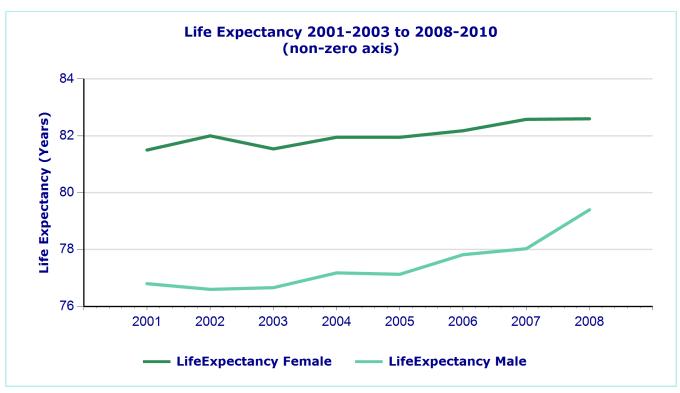
Goal 1 - Longer Healthier Lives

'To improve the health of our people by increasing the length of their lives and increasing the number of years they spend free from disease, illness and disability.'

Average life expectancy measures the expected years of life at birth based on the mortality rates of the period in question. The Northern Ireland average life expectancy for 2008-2010 is **77.1** years for males and **81.5** years for females. Life expectancy for males in **Magherafelt** LGD for 2008-2010 is **79.4** years, and for females is **82.6** years.

Life expectancy for males has increased by **1.5** years, and for females has increased by **1.1** years, over the period 2001-2003 to 2008-2010 in Northern Ireland. In **Magherafelt** LGD, life expectancy has increased by **2.6** years for males, and increased by **1.1** years for females over the same period.

In total **253** people died in 2010 in **Magherafelt**, of these **86 (34.0%)** were under 75 years old. Of all deaths, **71 (28.1%)** were to malignant neoplasms, **33 (13.0%)** were to respiratory disease and **89 (35.2%)** were to circulatory disease.

The median age at death was **80** in 2010 in **Magherafelt**.

Potential Years of Life Lost (PYLL) is a measure of premature death, measured as the number of years of life 'lost' from a death when a person dies before the age of 75. A death at age 25, for example, has lost 50 potential years of life. In **Magherafelt** LGD the PYLL per year per 100 population for 2006 to 2008 was **5.6** years for males and **3.1** years for females. The table below shows PYLL for different age groups for 2006-2008.

The Standardised Mortality Ratio is a method of comparing mortality in different populations, while allowing for differences in the age structure of these populations. The Northern Ireland rate is set equal to 100 and a value greater than 100 indicates above average mortality. In **Magherafelt** LGD the Standardised Mortality Ratio from 2008-2010 for all ages was **86.6**.

In **Magherafelt** LGD the standardised death rate (per 100,000 population) for the population under 75 years of age was **348.0** for males and **249.9** for females. The table below shows average death rates by cause for the population under 75 years of age.

Goal 2 - Reducing Inequalities

'To reduce inequalities in health between geographic areas, socio-economic and minority groups.'

Theme - Limiting Long-term Illness/Disability

There were **809** incidence of all cancers (excluding non-melanoma skin cancer) in **Magherafelt** in the 5 year period 2006-2010.

The Northern Ireland Cancer Registry provide a five year standardised cancer incidence ratio. The Northern Ireland rate is set equal to 100 and a value greater than 100 indicates above average incidence of cancer. See <u>link to dataset</u> for associated confidence intervals. The latest dataset available is for 2005-2009 and the standardised cancer incidence rate for all persons in **Magherafelt** LGD was **97.6**

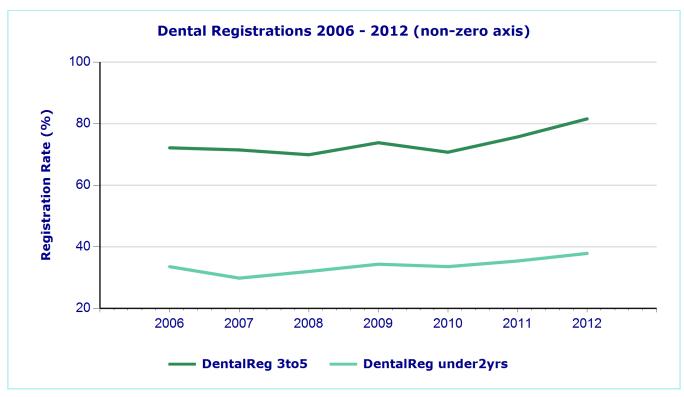
Theme - Access to Healthcare

In 2012 in **Magherafelt** LGD **37.9%** of children aged 0-2 years and **81.5%** of children aged 3-5 years were registered with a dentist. The chart below shows trend data from 2006.

Dental registrations in **Magherafelt** LGD for children aged 0-2 years increased by **4.3** percentage points, and for children aged 3-5 years have increased by **9.4** percentage points, over the period 2006 to 2012. In Northern Ireland there was an increase of **5.0** percentage points for children aged 0-2 years and an increase of **12.1** percentage points for children aged 3-5 years over the same period (based on unrounded calculations).

For **Magherafelt** LGD in 2007 **96.9%** of children received immunisation for Measles, Mumps, Rubella (MMR) before reaching their second birthday.

For Magherafelt LGD the median ambulance response time for incidents in 2011 was 9.23 in minutes and seconds.

Standardised admission rates to hospitals are available for all hospital admissions by type and by cause. The Northern Ireland rate is set equal to 100 and a value greater than 100 indicates an above average standardised admission rate. In 2010/11, in **Magherafelt** LGD:

- The standardised admission rate for all admissions was 106.8;
- The standardised admission rate for elective admissions was 110.8;
- The standardised admission rate for emergency admissions was 102.8;
- The standardised admission rate for respiratory admissions (2008/09-2010/11) was 114.4 and
- The standardised admission rate for circulatory admissions (2008/09-2010/11) was **109.9** .

Objective 1 - Poverty

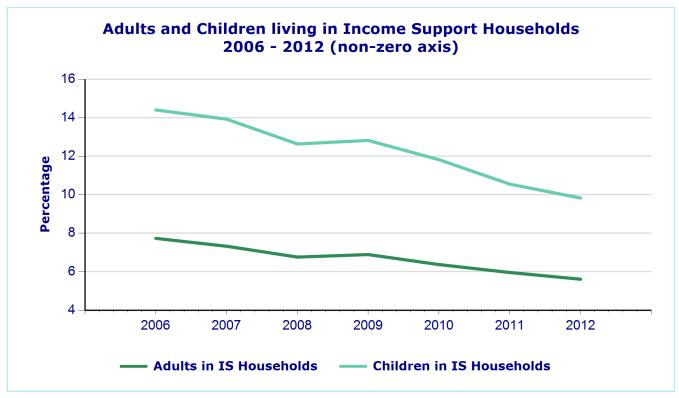
'To reduce poverty and social exclusion especially in families with children.'

In 2012 in **Magherafelt** LGD **5.6%** of adults and **9.8%** of children aged under 16 were living in Income Support households. The chart below shows trend data from 2006.

The percentage of adults living in Income Support households has decreased by **2.1** points, and the percentage of children living in Income Support households has decreased by **4.6** percentage points, over the period 2006 to 2012 in **Magherafelt** LGD. In Northern Ireland there was a decrease of **2.9** percentage points for adults and a decrease of **5.6** percentage points for children living in Income Support households over the same period.

In 2011/12 **14.3%** of pupils in post-primary schools had Free School Meal Entitlement (based on pupil residence data).

In 2010 **43.7%** of resident births in **Magherafelt** LGD were recorded to parents with medium/low or unknown social class as defined by the National Statistics Socio-economic Classification (NS-SeC) which is principally based on an individual's occupation and employment status.

Further social security benefit information in 2012 for **Magherafelt** LGD is as follows:

- 1,260 persons aged 16 and over were claiming Income Support;
- 2,390 persons aged 60 and over were claiming Pension Credit;
- 1,080 persons aged 16-64 were receiving Incapacity Benefit; and
- 2,640 persons aged 16+ were claiming Housing Benefit.

Small Area Income Deprivation Estimates

Small Area Income Deprivation Estimates are available for the years 2003/05. Outputs include estimates of the incidence of income poverty (as measured by the proportion of households whose income is below 60% of the UK median household income). Data on households in relative poverty (%) available for 2004/05 is based on unequivalised gross income before housing costs and data available for 2003/05 is based on net income before housing costs, equivalised for household size/composition.

Northern Ireland Multiple Deprivation Measure

The Northern Ireland Multiple Deprivation Measure 2010 (NIMDM 2010) report was published in May 2010. The report identifies small area concentrations of multiple deprivation across Northern Ireland. The results for **Magherafelt** LGD are shown below.

Magherafelt LGD has an Extent of **2%**, this means that **2%** of the **Magherafelt** population live in the most deprived Super Output Areas in Northern Ireland.

The Income Scale shows that there are **9,314** people in **Magherafelt** LGD experiencing income deprivation, while the Employment scale shows that a total of **3,052** people in **Magherafelt** LGD experience employment deprivation.

Both the Income Scale and the Employment Scale can be presented as rates of the relevant population. **21%** of the population in **Magherafelt** LGD were identified as income deprived while **12%** were identified as employment deprived. This can be compared to NI as a whole where 25% were identified as income deprived and 13% employment deprived.

Objective 2 - Education & Skills

'To enable all people and young people in particular to develop the skills and attitudes that will give them the capacity to reach their full potential and make healthy choices.'

Qualifications and Students

In 2010/11 **75.0%** of pupils achieved the expected level in Maths and **75.0%** of pupils achieved the expected level in English (Level 4 or above) in Key Stage 2 Assessments in the most disadvantaged primary schools (25% of schools with highest Free School Meals Entitlement) in **Magherafelt** LGD. The graph below shows trend data from 2005/06.

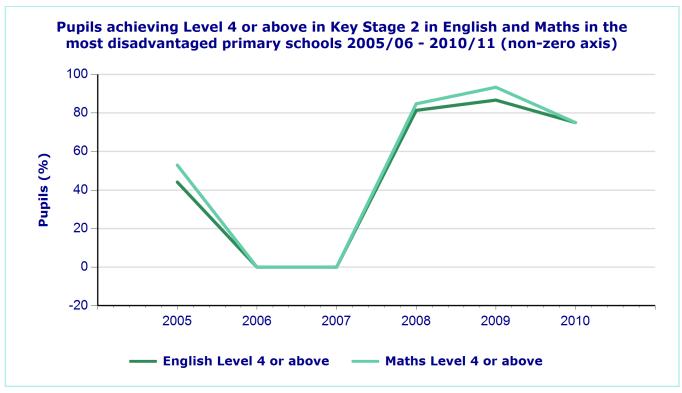
This compares to **82.2%** of pupils who achieved the expected level in Maths and **83.9%** of pupils who achieved the expected level in English (Level 4 or above) in Key Stage 2 Assessments in *all schools* in **Magherafelt** LGD in 2010/11.

In **Magherafelt** LGD of those who left school in 2010/11, **79.4%** gained 5 or more GCSEs at grade C and above. The graph below shows trend data from 1998/99.

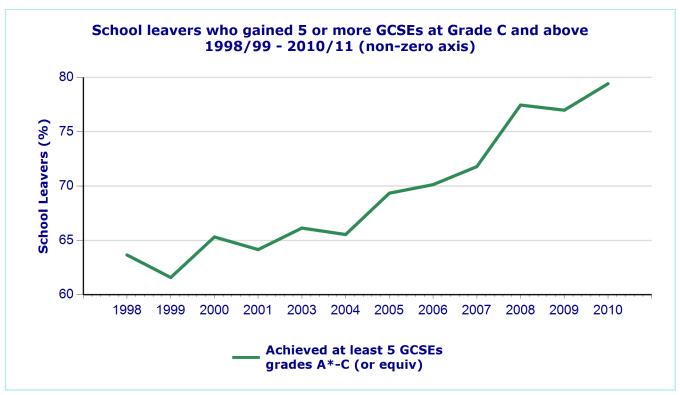
The percentage of school-leavers who gained 5 or more GCSEs at grade C and above has increased by **15.8** points in **Magherafelt** LGD over the period 1998/99 to 2010/11. In Northern Ireland there was an increase of **16.1** percentage points for school-leavers who gained 5 or more GCSEs at grade C and above over the same period (based on unrounded calculations).

In **Magherafelt** LGD there were **2,530** Students enrolled at a Further Education college in 2010/11. Of these, **25.0%** were full time and **75.0%** were part time students, while **45.0%** were female and **55.0%** were male. Further Education can be defined as post-secondary education (in addition to that received at secondary school), that is distinct from the education offered in universities.

In **Magherafelt** LGD there were **1,685** students enrolled at a Higher Education college in 2010/11. Of these, **79.6%** were full time and **20.4%** were part time students, while **62.1%** were female and **37.9%** were male. Higher education can be defined as education at a higher level than secondary school, usually provided in distinct institutions such as universities.

Note: Percentages for gender may not sum to 100 due to rounding of data.

School Census data for 2010/11 (by pupil residence) in **Magherafelt** LGD shows that **13.8%** of pupils in post-primary schools are categorised as Statemented or with Special Education Needs (SEN) Stage 1 to 4. Statemented pupils are those pupils with a statement of special educational needs, i.e. pupils at stage 5 on the Special Educational Needs (SEN) Code of Practice.

The Quality and Outcomes Framework (QOF) measures general practice achievement against a range of evidence-based indicators and provides raw disease prevalence data by a total of 17 clinical areas. In 2012, the raw prevalence of patients aged 18 plus (per 1,000 patients) on the Learning Disabilities Register was **7.8** for **Magherafelt** LGD.

Objective 3 - Mental Health & Emotional Well Being

'To promote mental health and emotional well-being at individual and community level.'

The Quality and Outcomes Framework (QOF) measures general practice achievement against a range of evidence-based indicators and provides raw disease prevalence data by a total of 17 clinical areas. In 2012, the raw prevalence of patients (per 1,000 patients) on the Mental Health Register was **7.2** and on the Dementia Register was **4.3** for **Magherafelt** LGD.

In **Magherafelt** LGD there were **3** admissions to hospital as a result of mood or anxiety disorder in 2009/10. The data is extracted from the Northern Ireland Hospital Inpatients System (HIS), but excludes mental health specialities as not all mental health information is recorded on the Patient Administration System. Trend data from 2004/05 is shown in the graph below.

Aggregated hospital admissions data is also available for the age standardised rate of admissions due to self-harm. The Northern Ireland rate is set equal to 100 and a value greater than 100 indicates an above average admission rate. From 2005/06-2009/10 the admission rate was **65.8** in **Magherafelt** LGD.

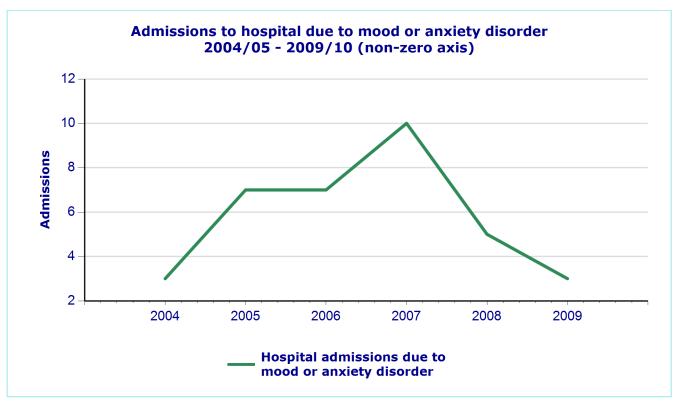
GP prescribing data is available to provide an estimate of the percentage of the population who are receiving drugs for mood or anxiety disorders. In **Magherafelt** LGD **9.6%** of people were prescribed anxiolytic and anti-depressant drugs in 2008. Trend data from 2004 is shown in the graph below.

The percentage of the population who are receiving drugs for mood or anxiety disorders has increased by **2.0** points in **Magherafelt** LGD over the period 2004 to 2008. In Northern Ireland there was an increase of **2.3** percentage points for the population who are receiving drugs for mood or anxiety disorders over the same period (based on unrounded calculations).

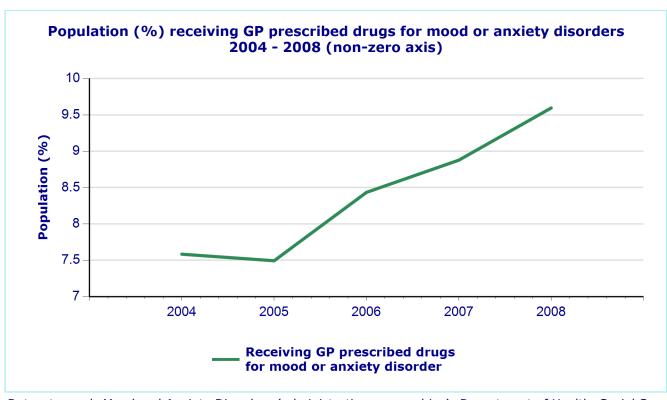
Data is recorded on the number of deaths due to suicide and undetermined intent from 1999 to 2010. In **Magherafelt** LGD there were **4** such deaths in 2010. Trend data from 1999 is shown in the graph below.

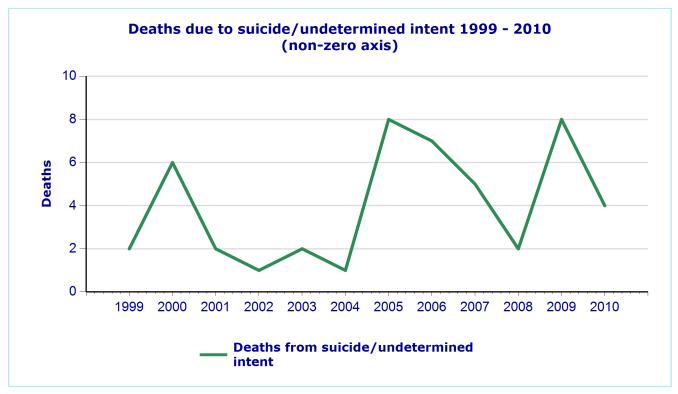

Objective 4 - Healthy Environments

'To offer everyone the opportunity to live and work in a healthy environment and to live in a decent affordable home.'

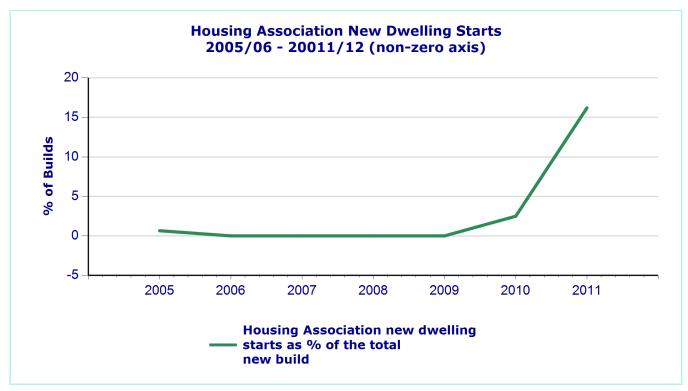
The 2006 House Conditions Survey showed that in **Magherafelt** LGD:

- 4.7% of homes were assessed as unfit;
- 4.3% of homes had a Standard Assessment Procedure* rating of less than 20;
- 7.4% of homes were dependent on solid fuel or electricity as a source of heating; and
- **34.2%** of homes were in fuel poverty.

*The Standard Assessment Procedure is the Government's standard method for rating the energy efficiency of a dwelling. The SAP rating provides a comparative measure of the energy efficiency of dwellings; the lower the score the lower the energy efficiency, the higher the score - up to a maximum of 120 - the higher the efficiency.

In 2011/12 there were **328** new dwelling starts in **Magherafelt** LGD, **53** of these were for Housing Associations, representing **16.2%** of the total new build. The graph below shows trend data from 2005/06.

Objective 5 - Neighbourhood Renewal

'To improve our neighbourhoods and wider environment.

In **Magherafelt** LGD **5.9%** of cars were registered to a disabled driver or for transporting disabled people in 2010.

There were **1,076** incidents of anti-social behaviour recorded by the Police Service Northern Ireland in **Magherafelt** LGD in 2011/12.

Hate incidents are defined as any incident which is perceived by the victim, or any other person, as being motivated by prejudice or hate. The hate motivation definitions used are racist (a group of persons defined by reference to race, colour, nationality or ethnic or national origins and includes the Irish Traveller community), homophobic (fear or dislike directed towards lesbian, gay or bisexual people, or a fear or dislike directed towards their perceived lifestyle, culture or characteristics) and sectarian (a term almost exclusively used in Northern Ireland to describe incidents of bigoted dislike or hatred of members of a different religious or political group). In **Magherafelt** LGD in 2011/12, there were **11** racist, **4** homophobic and **34** sectarian offences.

There were a total of **1,630** offences recorded in **Magherafelt** LGD in 2011/12. The rates per 10,000 population by type of crime are shown below:

- Violent crimes (offences against the person, sexual offences and robbery) 120.7;
- Criminal damage 92.3;
- Burglary **28.6**; and
- Theft 13.9

There were **112** noise complaints made in **Magherafelt** LGD in 2010/11, which is equal to a rate of **2.5 per 1,000 population**.

In **Magherafelt** LGD in 2011/12, **60.2%** of household waste was recycled and composted and **59.1%** of local authority collected municipal waste was recycled and composted.

In **Magherafelt** LGD there were **158** people who completed the Enterprise Development Programme provided by Invest NI in 2010/11. Of these, **70.9%** subsequently started a business.

Objective 6 - Accidental Injury

'To reduce accidental injuries and deaths in the home, workplace and from collisions on the road.'

In Magherafelt LGD in 2009/10 there were **346** hospital admissions due to accidents. Of these:

There were **50** admissions as a result of injuries due to road traffic collisions in 2009/10. This represents **14.5%** of all hospital admissions due to accidents. These can be broken down by age:

- 0-4 years **6.0%**
- 5-15 years **10.0%**
- 16-64 years **72.0%**
- 65 years and over **12.0%**

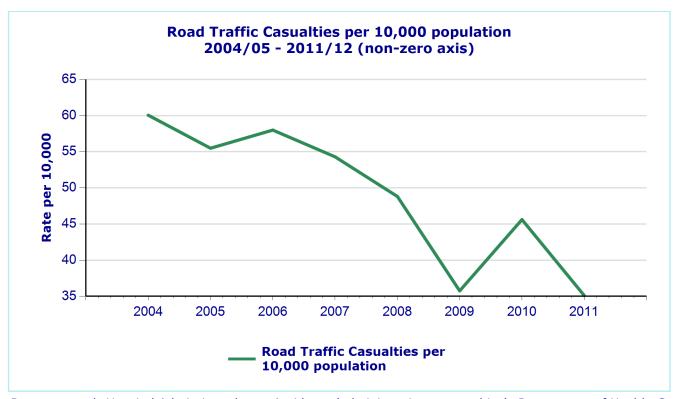
There were **47** admissions as a result of injuries in the home in 2009/10. This represents **13.6%** of all hospital admissions due to accidents. These can be broken down by age:

- 0-4 years **25.5%**
- 5-15 years **6.4%**
- 16-64 years 27.7%
- 65 years and over **40.4**

There were **10** admissions to hospital due to accidental injuries occurring at school. This represents **2.9%** of all hospital admissions due to accidents in 2010.

There were **100** road traffic collisions in **Magherafelt** LGD in 2011 which resulted in **2** people being killed. In total there was a rate of **35** road traffic casualties per 10,000 population in 2011 (this includes all persons slightly injured, seriously injured and killed). The graph below shows trend data from 2004/05.

Objective 7 - Healthier Choices

'To enable people to make healthier choices.'

There were **3** alcohol-related deaths in **Magherafelt** LGD in 2010 . The definition of alcohol-related deaths includes deaths with a clear causal relationship to alcohol consumption.

There were **3** drugs-related deaths in **Magherafelt** LGD in 2010. The definition of drugs-related deaths is when the underlying cause of death recorded on the death certificate is drug poisoning, drug abuse or drug dependence.

There were **2** obesity-related deaths in **Magherafelt** LGD from 2006 to 2010. The definition of obesity-related deaths is any death where the underlying cause of death is recorded as obesity.

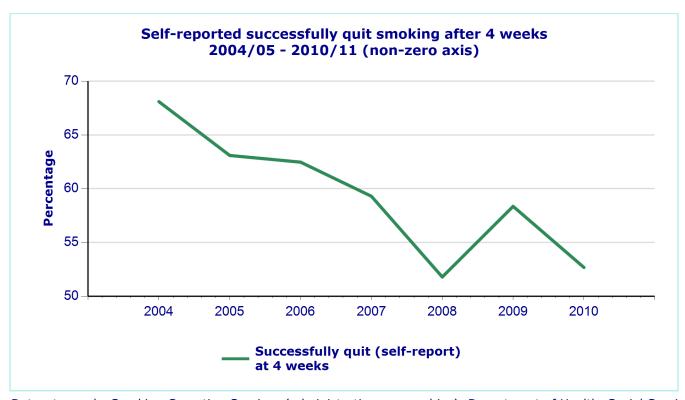
The Quality and Outcomes Framework (QOF) measures general practice achievement against a range of evidence-based indicators and provides raw disease prevalence data by a total of 17 clinical areas. In 2012, the raw prevalence of patients aged 16 plus (per 1,000 patients) on the Obesity Register was **100.5** for **Magherafelt** LGD.

Data on individuals availing of specialist smoking cessation services shows that in **Magherafelt** LGD in 2010/11, **52.7%** of people who set a quit date had successfully quit (self-report) at 4 weeks. Trend data from 2004/05 is available in the graph below.

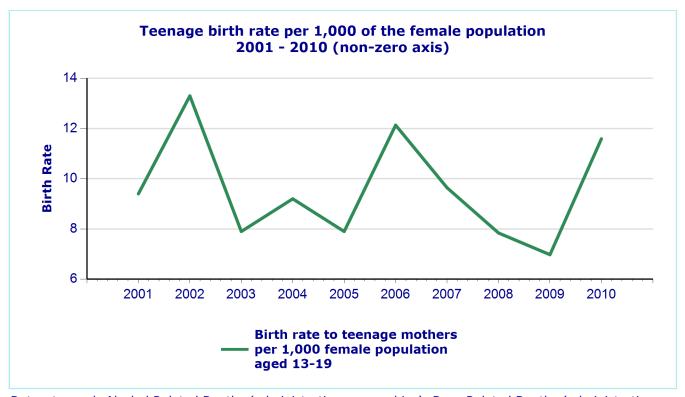
Births data for 2010 shows that the teenage birth rate per 1,000 of the female population aged 13-19 was **11.6%** in **Magherafelt** LGD. Trend data from 2001 is available in the graph below.

The teenage birth rate per 1,000 of the female population aged 13-19 in **Magherafelt** LGD increased by **2.2** between 2001 to 2010 from **9.4** to **11.6**. The Northern Ireland teenage birth rate per 1,000 of the female population aged 13-19 decreased by **1.9** for the same period, from **16.9** to **15.0**.
